### **In the bee yard:**

- Consider reducing the hive entrance to a medium setting (approximately 3 inches) to protect against robbing. As the temperatures begin to drop next month, consider reducing down further to the smallest setting to prevent mouse intrusion.
- Mite treatments should be completed by September so the hive can produce healthy winter bees. Check the mite levels in your hives 2 weeks after treatments to see if the treatments were effective. For instructions and videos on how to check for mites, go to the [Honey Bee Health Coalition](#) website <click [here](#)>. If you are using a sticky board to monitor, the treatment threshold is 40 mites in a 24-hour period. If you are using the sugar roll method, 3 to 4 mites per 100 bees is the treatment threshold. The sugar roll method is considered the more accurate of the two monitoring methods.
- Check one month after the conclusion of mite treatments to ensure your colony is queen right (you see brood – eggs, larvae, pupae).
- If you have a weak colony or a failing queen, consider removing the queen and combining the hive with a strong colony.
- If you have double deep or double/triple medium hive bodies and the brood is at the top, rearrange frames or hive bodies by mid-October so the brood is on the bottom and food stores are on the top. Bees will tend to cluster around the brood when temperatures drop and the cluster will move up during the winter.
- If your hive is light on stored honey, feed your bees sugar water either 1:1 concentration this month to stimulate queen laying and 2:1 concentration next month to build up food stores for the winter.

### **BeeCheck:**

BeeCheck allows hive owners to map the locations of beehives. Pesticide applicators can access databases before treating a field to identify sensitive sites that are close to the spray areas. Beekeepers can access and sign up for BeeCheck at <https://beecheck.org/>. The website offers detailed instructions on how to sign up and use the mapping tools. Beekeepers map their hives using pins and half-acre circles and can choose which details of hive information are displayed on the map. It is not a substitute for any state regulatory requirements.
